APPLICATION FOR A PIPELINE LICENCE BY THE NATIONAL GAS COMPANY OF TRINIDAD AND TOBAGO LIMITED

PURSUANT to section 7 of the Petroleum Act, Chap. 62:01, notice is hereby given that an application for a pipeline licence has been made by the National Gas Company of Trinidad and Tobago Limited to construct, install, maintain and operate a pipeline as described in the attached Schedule along the route indicated in the attached map marked "A".

Any person may object to the issue of the above-mentioned licence on the ground that it is inconsistent with, or would interfere with, rights held by him under the Petroleum Act, Chap. 62:01.

SCHEDULE ABOVE REFERRED TO—DESCRIPTION OF PIPELINE

Route

The proposed 914.40 mm (36.00-inch) North Eastern Offshore (NEO) pipeline will begin from a 914.40 mm (36.00-inch) riser on the Gas Export Platform located approximately 35.40 km (22.00 miles) off the northeast Coast of Trinidad, and run parallel to the existing 457.2 mm (18.00-inch) oil pipeline for approximately 84.00 km (52.20 miles) along the seafloor. At the Horizontal Directional Drill (HDD) section, the NEO pipeline will cross under the existing 762.00 mm (30.00-inch) gas pipeline. This offshore line segment will terminate at the landfall point of the HDD shore approach in the vicinity of the Mayaro Regulator Station. See Reference Map "A".


