An official receipt must be attached to the tender for the relevant Schedule showing that a tender deposit of five hundred dollars (\$500.00) in respect of each Schedule has been paid. This tender deposit will be received by cash or certified cheque payable to the Director of Contracts, from Monday to Friday between the hours of 9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m. The unsuccessful tenderers will be refunded their deposits after contracts are awarded.

The successful tenderers will be required to pay a Cash Performance Deposit or provide a Bond in amounts varying between five hundred dollars (\$500.00) and twenty-five thousand dollars (\$25,000.00) depending on the value of the contract.
