THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO has received financing from the Inter-American Development Bank (IDB) and intends to apply part of the proceeds to payments under the project Electronic Government and Knowledge Brokering Program for the Design of a Records and Information Management (RIM) Framework for the Trinidad and Tobago Public Service.

This consultancy is being sought so as to provide the Ministry of Public Administration with expertise, technical knowledge and skill to develop a records and information management framework to modernize and transform the treatment of information and records as is used by the Public Service. This framework in-keeping with international best practices will establish a strong foundation from which additional, supporting RIM related projects are to be undertaken with success. The Consultancy is expected to involve an investigation into the existing RIM at the macro/Public Service level, and provide a final recommendation based on best practices and benchmarks that would be modified for adoption by the Trinidad and Tobago Public Service at both the micro and macro levels.

The estimated duration of the assignment is seven (7) months.
