THE CITIZEN SECURITY PROGRAMME (CSP) is an initiative of the Ministry of National Security that is partially financed by the Inter-American Development Bank (IDB) through a loan facility. The objective of the programme is to contribute to the reduction of crime and violence within 22 “high needs” communities throughout Trinidad and Tobago. The CSP will accomplish this through the financing of preventative interventions addressing the most proximal and modifiable risk factors.

The specific objectives of the Programme are (i) the reduction in the levels of homicides, robberies and woundings in partner communities; (ii) an increase in the perception of safety in the partner communities; (iii) a reduction of injuries related to firearms, child maltreatment, domestic violence and youth violence; and (iv) an increase in the collective efficacy to prevent violence in the partner communities.

To this end, the Programme’s activities have been organized into three (3) main components: (1) Community Action; (2) Assistance to the Trinidad and Tobago Police Service (TTPS); and (3) Institutional Strengthening of the Ministry of National Security.
