TENDER FOR THE SUPPLY AND INSTALLATION OF AN UNMANNED AERIAL VEHICLE MAPPING SYSTEM AND TERRESTRIAL LASER SCANNER FOR THE DIVISION OF LAND AND SURVEYS, MINISTRY OF HOUSING, LAND AND MARINE AFFAIRS, GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) INTER-AMERICAN DEVELOPMENT BANK (IDB) LOAN NO. 1808/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO *via* the Ministry of Public Administration has received financing from the Inter-American Development Bank (IDB) and intends to apply part of the proceeds to payments under the project Electronic Government and Knowledge Brokering Program for the Supply and Installation of an Unmanned Aerial Vehicle Mapping System and Terrestrial Laser Scanner for the Division of Land and Surveys, Ministry of Housing, Land and Marine Affairs.

The Division of Land and Surveys is seeking to procure an Unmanned Aerial Vehicle Mapping System and Terrestrial Laser Scanner that will facilitate the co-ordination of aerial photography and provide updated mapping. The Unmanned Aerial Vehicle (UAV) would be used to provide coloured map and imagery products to serve the identical purpose of conventional aerial survey and to satisfy the needs of a demanding spatial data market. The terrestrial laser scanner equipment is expected to allow high precision surveying from the ground and would complement the work of the UAV system. Used together this equipment would allow the Division of Land and Surveys to meet the needs of the users whose spatial data requirements are of very high precision.

The services provided by this solution will allow the Division to effectively carry out its land management activities and to also to assist other State and private agencies in their developmental planning. To enable this, complete UAV and Laser Scanner systems, inclusive of vehicles, sensors, hardware and software are being procured.

The equipment and services to be provided for this specific component include but are not limited to-

- 1. Supply a complete UAV and sensor system for the conduct of aerial photographic data capture able to produce large scale digital photographs to be used in the production of orthophotos and digital terrain models.
- 2. Supply a terrestrial laser scanner system for the conduct of high resolution terrain mapping data capture.
- 3. Train and certify relevant personnel in the operations of the UAV and Laser Scanner systems.
- 4. Execute a field completion and validation exercise of both UAV and Laser Scanner systems.
- 5. Supply testing and maintenance tools, radio communication sets and binoculars.
- 6. Supply ruggedized field and high-end workstation computers.

The Central Tenders Board on behalf of the Ministry of Public Administration now invites sealed bids from eligible bidders to provide the Division of Land and Surveys with the Supply and Installation of an Unmanned Aerial Vehicle Mapping System and Terrestrial Laser Scanner. Bidding will be conducted through international competitive bidding procedures as specified in the Inter-American Development Bank's *Policies for Procurement of Works and Goods financed by the Inter-American Development Bank* (current edition) and is open to all eligible bidders as defined in the policies which can be found at website: http://www.iadb.org/procurement.

Bidding documents may be obtained during normal working hours from Monday to Friday during office hours 8.00 a.m. to 4.00 p.m. at the Central Tenders Board's Office, at address (1) below.

Any further technical information can be obtained during normal working hours from address (2) below from Monday to Friday during office hours 8.00 a.m. to 4.00 p.m. (local time).

A pre-bid meeting will be held for prospective bidders on Friday 6th September, 2013 at at 9.30 a.m. at the Land and Surveys Division, Ministry of Housing, Land and Marine Affairs, 118, Frederick Street, Port-of-Spain.

Proposals must be accompanied by the following where applicable:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for the submission of proposals;
- (b) valid Certificate of Compliance issued in accordance with the National Insurance Act.

Bidders are also required to provide a bid security in the sum of fifty thousand Trinidad and Tobago Dollars (TT\$50,000.00) or equivalent in United States Dollars established by a recognized financial institution with their bid.
