THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO via the Ministry of Public Administration has received financing from the Inter-American Development Bank (IDB) and intends to apply part of the proceeds to payments under the project Electronic Government and Knowledge Brokering Program for an Aerial and Lidar Survey of Trinidad and Tobago for the Division of Lands and Surveys, Ministry of Housing, Land and Marine Affairs.

The Division of Lands and Surveys is seeking to acquire new digital aerial photography of approximately 5,100 km<sup>2</sup>, covering the area of Trinidad and Tobago during the 2014 Dry Season. This photography is a result of the heightened awareness for good spatial data and the need for present-day coverage of a mosaic of remotely sensed imagery of Trinidad and Tobago. The processing of the aerial photography should produce orthophotographs and digital terrain models. The duration of this assignment shall be twelve (12) months.

The Central Tenders Board on behalf of the Ministry of Public Administration now invites sealed bids from eligible bidders to conduct an Aerial and Lidar Survey of Trinidad and Tobago for the Division of Lands and Surveys, Ministry of Housing, Land and Marine Affairs.
