Project: Provision of Consulting Services by Individuals in the Area of Assessing Programme Content followed by the Designing and Implementing of Training Modules in Numeracy and Literacy at the Levels of Infants and Standards 1 for the Ministry of Education (MOE)—IDB Loan No. 2138/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received financing from the Inter-American Development Bank (IDB) and has been applying part of the proceeds to payments under the project, Support for a Seamless Education System Porgramme (SES) (LO2138/OC-TT). This is in keeping with the Government's official policy for development of the Education System and the nation's children through its transformation initiative.

Integral to the success of this Programme and the Ministry of Education's (MOE) transformation initiative is the completion of several complex educational projects, all of which are aimed at improving the capabilities of the nation's children, with the secondary target being the strengthening of the MOE's capacity, which is a necessary pre-requisite for devising and implementing strategies for the achieving of the MOE's goals for the Educational System and its children.

With the suggestion of gaps in the numerical and literary capability of its children at the lower education levels, the MOE's strategies have embraced several steps including the purchasing of materials, the placement of coaches and the engagement of its Curriculum Division officers, with the main targets being the infants and standard 1 pupils. The current project involves the recruiting of individual consultants to study the contents of the MOE's Numeracy and Literacy Programme, to design modules for training the MOE's coaching and curiculum teams in the deployment of both the materials to be purchased and the existing items, and to implement the training and prepare reports thereon. The MOE has already prepared the necessary Terms of Reference documentation to govern the scope of services of the individual consultants.

The recruitment methodology applicable in this instance involves the issuing of a Specific Procurement Notice (SPN) to attract Curriculum Vitae submissions from interested candidates followed by the assessment of the qualifications, experiences, expertise and knowledge and understanding of the interested candidates.

Accordingly, on behalf of the Ministry of Education, the Central Tenders Board invites eligible individuals to submit their updated Curriculum Vitae (CV) documentation with accessible references, to be considered for the following consulting projects:

- Project 1—Instructional Strategies in Primary Mathematics
 Use of Instructional Materials to Develop Students Mathematical Understanding
 Differentiated Instruction in Numeracy and Mathematics
 Assessment in Mathematics
- Project 2—Effective Coaching Techniques with Specific Reference to the Teaching of Numeracy and Mathematic and the Teaching of English and Literacy.
- Project 3—Systemic Use of Data Arising from Diagnoses and Assessments of Mathematics, English and Reading Literacy.
- Project 4—Designing, Planning and Implementing Effective School-Based Interventions in Early Literacy as well as in Literacy and Numeracy Reading across the Curriculum.
