IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Ammar Samaroo, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the Private Warehouse of Messrs. Sterling Service (Battoo Bros.) Limited, No. 70 Sackville Street, Port-of-Spain–Vans, Pick-ups, Trucks, Cars and such other goods as I may subsequently approve.
