IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Ammar Samaroo, Acting Comptroller of Customs and Excise acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Warehouse for the storage, pending entry for the home consumption or export, of the following goods, as shall be warehoused by or in the Private Warehouse of VF Packaging Ltd., Corner Chanka Trace and El Socorro Extension No. 2, San Juan, plastic and plastic products and such other goods as I may subsequently approve.

SCHEDULE

A rectangular area measuring 12.1 metres by 6.1 metres by 3.6 meters comprising 265.7 cubic metres, situated on the ground floor of Magical Holdings Complex located at Corner of Chanka Trace and El Socorro Extension No. 2, San Juan.

It is constructed of 6 inch by 6 inch BRC Wire supported by seven 2 inch by 6 inch by 12ft. lengths of Pitch Pine Wood, four uprights on the southern side and three on the eastern side.
