INDEX OF RETAIL PRICES—April, 2014 (Base: January, 2003 = 100)

GENERAL INDEX

The All Items Index of Retail Prices calculated from the prices collected for the month of April, 2014 was 219.7 representing an increase of 0.6 points or 0.3% above the All Items Index for March, 2014.

The percentage change in the All Items Index for the period January to April, 2014 over the period January to April, 2013 was 3.6%. This reflects a decrease when compared with the rate of inflation of 6.4% observed in the All Items Index for the period January to April, 2013 over the period January to April, 2012.

## SECTION INDICES

## FOOD AND NON-ALCOHOLIC BEVERAGES

The Index for Food and Non-Alcoholic Beverages decreased from 574.6 in March, 2014 to 573.4 in April, 2014, reflecting a decrease of 0.2%. Contributing significantly to this decrease was the general downward movement in the prices of melongene, ochroes, yams, tomatoes, pumpkin, oranges, sweet peppers, sweet potatoes, mangoes and avocado. However, the full impact of these price decreases was offset by the general increase in the prices of cucumbers, dasheen, celery, hot peppers, chive/thyme, limes, irish potatoes, canned vegetables, carrots and ripe bananas.

Price changes in this section for the month of April, 2014 accounted for a net overall decrease of 0.2 points in the All Items Index.

#### OTHER SECTIONS

A further review of the data for April, 2014 compared with March, 2014 reflected increases in the sub-indices for Alcoholic Drinks and Tobacco of 0.5%, Housing, Water, Electricity, and Gas 0.2%, Furnishings, Household Equipment and Routine Maintenance of House of 0.3%, Health 1.0%, Transport 0.7%. Recreation and Culture 1.5%, Education 5.2%, Hotels, Restaurants and Cafes 1.6%, and Miscellaneous Goods and Services 0.5%. However a decrease was noted in the sub-index for Clothing and Footwear of 1.3%.

Price changes in the Other Sections for the month of April, 2014 accounted for a net overall increase of 0.8 points in the All Items Index.
