# APPOINTMENT OF A PRIVATE WAREHOUSE

Excise (General Provisions) Act, Chap. 78:50)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Excise (General Provisions) Act, Chap. 78:50, I, Ammar Samaroo, Acting Comptroller of Customs and Excise, acting under the provisions of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Excise Warehouse for the storage of, spirits manufactured in Trinidad and Tobago under the Excise laws, as shall be warehoused by or in the Private Warehouse of Messers. Trinidad Distillers Limited, Corner Eastern Main Road and Trinity Avenue, Laventille and such other goods as I may subsequently approve.

## SCHEDULE

A rectangular area measuring 13.1 metres by 6.7 metres comprising 87.77 square metres enclosed on the north, partly by a concrete wall to a height of 4.67 metres and B.R.C. wire mesh to a height of 3.06 metres (altogether a height of 7.73 metres), south partly by a concrete bund wall to a height of 1 metre and B.R.C wire mesh to a height of 6.73 metres (altogether to a height of 7.73 metres), east partly by a concrete wall with ventilation blocks to a height of 2.8 metres and B.R.C. wire mesh to a height of 4.93 metres (altogether to a height of 7.73 metres), west partly by a concrete wall to a height of 2.74 metres and B.R.C. wire mesh to a height of 2.81 metres (altogether to a height of 5.5 metres), with two entrances also used as exits located on the Southern and North-Eastern side and covered by steel and galvanized sheets.

The aforesaid area is to be called "Warehouse No. 16" containing three cylindrical stainless steel tanks as follows:

Tank No. 1, with a working volume of 20,269 litres;

Tank No. 2, with a working volume of 20,291 litres; and

Tank No. 3, with a working volume of 18,164 litres;

The aforesaid area is located in the south-eastern corner of the Trinidad Distillers Limited Distillery Complex, situate at corner Eastern Main Road and Trinity Avenue, Laventille, bounded by a condenser holding passageway on the north, a thoroughfare to the south, a parking lot on the east and a roadway/delivery truck access point to the west. The said Trinidad Distillers Limited Distillery Complex is bounded on the north by the Eastern Main Road, on the south by the Priority Bus Route, on the east by Trinity Avenue, and on the west by lands owned or occupied by Telecommunications Services of Trinidad and Tobago.
