IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Excise (General Provisions) Act, Chap. 78:50, I, Ammar Samaroo, Comptroller of Customs and Excise, acting under the provisions of the said Act, do hereby appoint the place described in the Schedule hereunder to be a Private Excise Warehouse for the storage of Angostura Bitters manufactured in Trinidad and Tobago under the Excise Laws, as shall be warehoused by or in the Private Excise Warehouse of Messrs. Trinidad Distillers Limited, Corner Eastern Main Road and Trinity Avenue, Laventille and such other goods as I may subsequently approve.

Schedule

A rectangular area measuring 27.6 metres (north to south) by 9.1 metres (east to west) comprising 251.16 square metres, enclosed on the northern, southern, eastern and western sides by a concrete brick wall 7.3 metres high.
