APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Annabelle Marshall, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Hand Arnold (Trinidad) Limited, El Socorro Road Extension, El Socorro, San Juan—Wines, Whisky, Gin, Liqueurs, other spirits, Vodka, Cold Medicines, Assorted Toys, Juices, Assorted Foods, Baby Foods, Assorted Housewares and such other goods as I may subsequently approve.

SCHEDULE

An enclosed area measuring 18.8 metres by 18.1 metres, a total surface area of 340.28 square metres and situate on the south-eastern section of the Ground Floor of Hand Arnold (Trinidad) Limited Complex at El Socorro Road Extension, San Juan.

The eastern wall is constructed of solid concrete blocks and the northern and western sides are enclosed by BRC wire supported on steel frames with three rows of barbed wire at the top.

The southern side is a steel rolling door framed within the concrete wall. The roof is covered with galvanized iron sheets.

The property is bounded on the north by a vacant lot and Chootoo Road, on the south by Hand Arnold's main driveway and privately owned dwellings, on the east by Agostini's Limited and on the west by El Socorro Road Extension, San Juan.
