## LOSS OF CUSTOMS AND EXCISE IDENTIFICATION CARD

Mr. AZARD KHAN, Customs and Excise Extra Guard has reported that his Customs and Excise Identification Card, ID Card No. P6/10 was lost on 12th April, 2003.

The Identification Card is royal blue and measures 7 cm x 9 cm when closed and 14 cm x 9 cm when opened. It contains a coloured photograph of the holder along with his name, rank, ID No. and signature, as well as the signature of the Comptroller of Customs and Excise.

Should any person present himself with a view to impersonating the officer to whom the card was issued, the police should be notified immediately. Should the identification card be found, it should be returned to the Personnel Section, Customs and Excise Division, Abercromby Street, Port-of-Spain, or be reported to the nearest Police Station.

## TRINIDAD AND TOBAGO SECURITIES AND EXCHANGE COMMISSION

IN THE MATTER OF

THE SECURITIES INDUSTRY ACT, 1995

And

THE DE-REGISTRATION OF LIFE OF BARBADOS LIMITED

*[Pursuant to section 64(6) of the Securities Industry Act, 1995]*

WHEREAS:

- (1) Life of Barbados Limited was registered with the Commission as a Reporting Issuer on August 4, 1997, pursuant to section 64(1) of the Securities Industry Act, 1995;
- (2) On the 8th day of March, 2002, Barbados Mutual Life Assurance Society (now renamed Sagicor Financial Corporation and hereinafter referred to as "the company") made an offer to acquire all of the issued common shares of Life of Barbados Limited not already owned by it. As at the date of the offer the company beneficially owned or exercised control or direction over 10,558,817 common shares of Life of Barbados Limited;
- (3) On the 24th day of June, 2002, the company acquired 95% of the remaining issued common shares of Life of Barbados Limited;
- (4) On the 23rd day of July, 2002, the company invoked the provisions of section 186 of the Companies Act Chap. 308 of the Laws of Barbados to compulsorily acquire all of the remaining shares of Life of Barbados Limited. The company served notices on the dissenting offerees that it had received acceptances in excess of 90% of the shares to which the offer related and that the Company had taken up and paid for the shares of the offerees who accepted the offer. The notices further advised dissenting offerees that they were required to elect to either transfer their shares to the company on the terms on which the company acquired the shares of the accepting offerees or demand fair payment for their shares in accordance with sections 193-196 of the Companies Act, Chap. 308;
- (5) On the 21st day of August, 2002, the company sent notices pursuant to section 192 of the Companies Act, Chap. 308 to dissenting offerees advising them of the cancellation of their shares in Life of Barbados Limited as a result of the compulsory acquisition of the shares by the company;
- (6) By letter dated the 17th day of January, 2003, Life of Barbados Limited requested the Trinidad and Tobago Stock Exchange Limited to de-list its shares from the Exchange;
- (7) Section 45(1) of the Securities Industry Act, 1995 provides that no self-regulatory organization shall de-list a security admitted for quotation by it, unless it obtains an order from the Commission authorizing the de-listing;
- (8) By Order dated the 13th day of March, 2003, the Commission in exercise of the power conferred by section 45(1) of the Securities Industry Act, 1995, authorized the de-listing of the shares of Life of Barbados Limited from the Trinidad and Tobago Stock Exchange;
- (9) On the 8th day of May, 2003, the Trinidad and Tobago Stock Exchange Limited de-listed Life of Barbados shares from the Exchange;
- (10) By letter dated the 23rd day of April, 2003, Life of Barbados Limited applied under section 64(6) of the Securities Industry Act, 1995 to the Commission for an Order declaring that Life of Barbados Limited was no longer a Reporting Issuer;
- (11) By letter dated the 24th day of June, 2003, Life of Barbados Limited applied for a determination under section 6(3) of the Companies Act, Chap. 81:01 that its issued shares and debentures are not part of a distribution to the public;
- (12) As a consequence of the aforementioned corporate events, the shares of Life of Barbados Limited are no longer publicly held;
- (13) On the 26th day of June, 2003, the Commission determined pursuant to section 6(3) of the Companies Act, Chap. 81:01 that the issued shares and debentures of Life of Barbados were not part of a distribution to the public;
- (14) The Commission is satisfied that the order sought under section 64(6) of the Securities Industry Act, 1995 would be in conformity with the provisions of the Securities Industry Act, 1995;

Now, therefore, in exercise of the power conferred by section 64(6) of the Securities Industry Act, 1995, the Commission hereby orders that Life of Barbados Limited is no longer a Reporting Issuer.

WHEREAS:

- (1) Life of Barbados Limited was registered with the Commission as a Reporting Issuer on August 4, 1997, pursuant to section 64(1) of the Securities Industry Act, 1995;
- (2) On the 8th day of March, 2002, Barbados Mutual Life Assurance Society (now renamed Sagicor Life Inc. and hereinafter called the "Company") made an offer to acquire all of the issued common shares of Life of Barbados Limited not already owned by it. As at the date of the offer the Company beneficially owned or exercised control or direction over 10,558,817 common shares of Life of Barbados Limited;
- (3) On the 24th day of June, 2002, the Company acquired 95% of the remaining issued common shares of Life of Barbados Limited;
- (4) On the said 23rd day of July, 2002, the Company invoked the provisions of section 186 of the Companies Act, Chap. 308 of the Laws of Barbados to compulsorily acquire all of the remaining shares of Life of Barbados Limited. The Company served notices on the dissenting offerees that it had received acceptances in excess of 90% of the shares to which the offer related and that the Company had taken up and paid for the shares of the offerees who accepted the offer. The said notices further advised dissenting offerees that they were required to elect to either transfer their shares to the Company on the terms on which the Company acquired the shares of the accepting offerees or demand fair payment for their shares in accordance with sections 193–196 of the Companies Act, Chap. 308;
- (5) On the 21st day of August, 2002, Life of Barbados Limited sent notices pursuant to section 192 of the Companies Act, Chap. 308 to dissenting offerees advising them of the cancellation of their shares in Life of Barbados Limited as a result of the compulsory acquisition of the shares by the Company;
- (6) By letter dated the 17th day of January, 2003, Life of Barbados Limited requested the Trinidad and Tobago Stock Exchange Limited to de-list its shares from the Exchange;
- (7) Section 45(1) of the Securities Industry Act, 1995 provides that no self-regulatory organization shall de-list a security admitted for quotation by it, unless it obtains an order from the Commission authorizing the de-listing;
- (8) By Order dated the 13th day of March, 2003, the Commission in exercise of the power conferred by section 45(1) of the Securities Industry Act, 1995, authorized the de-listing of the shares of Life of Barbados Limited from the Trinidad and Tobago Stock Exchange;
- (9) On the 8th day of May, 2003, the Trinidad and Tobago Stock Exchange Limited de-listed Life of Barbados Limited's shares from the Exchange;
- (10) By letter dated the 24th day of June, 2003, Life of Barbados Limited applied to the Commission for a determination under section 6(3) of the Companies Act, Chap. 81:01 that its shares and debentures are not part of a distribution to the public;
- (11) As a consequence of the aforementioned corporate events, the shares of Life of Barbados Limited are no longer publicly held;
- (12) The Commission is satisfied that such a determination would not prejudice any shareholder or debentureholder of Life of Barbados Limited.

Now, therefore, the Commission hereby determines that the shares and debentures of Life of Barbados Limited are not part of a distribution to the public.
