## APPOINTMENT OF A PRIVATE WAREHOUSE

*(Customs Act, Chap. 78:01)*

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Ralph M. Newton, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Budget Marine Trinidad Limited of Western Main Road, Chaguaramas—Wind Generators, Solar Panels, Marine Batteries, Battery Chargers, Marine Stoves, Navigation/Communication Equipment and such other goods as I may subsequently approve.

### SCHEDULE

An enclosed area measuring 6.10 metres by 4.83 metres with a total area of 29.46 square metres on the ground floor of a building situate at Western Main Road, Chaguaramas.

The building consists of concrete walls and steel beams and is covered with galvanised sheets.

The area is bounded on the east by the Workshop Area, on the west by Power Boat Mutual Facilities Limited, on the north by the Retail area of Budget Marine Trinidad Limited and on the south by Skinner Marine Limited.
