The area is “L” shaped with the following measurements: 30.30 metres by 6.40 metres and 15.24 metres by 6.28 metres comprising a total surface area of 289.63 square metres. It is located in Warehouse No. 23, Unit 2, situate at Fernandes Industrial Centre, south of the Priority Bus Route, Laventille.

The eastern and western walls are constructed of concrete blocks and BRC wire and supported by steel frames extending to the roof. The northern wall is constructed of concrete blocks. The southern wall is constructed of BRC wire and supported by steel frames extending to the roof. The roof is constructed of galvanized sheets supported by steel beams.
