TENDERS are invited for the Piarco International Airport Runway Overlay works for the Ministry of Works and Transport.

Tenderers are advised that the use of Blended Lake Asphalt is mandatory for the Asphaltic Overlay.

Tenders must be accompanied by valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.

One original and six (6) copies each of the Technical and Price Proposal should be submitted separately. The Technical Proposal should contain data such as Technical Evaluation questionnaire, work methodology, execution plan, personals qualification organization and management etc. The Price Proposal should contain the completed Form of Tender, Bills of Quantities etc. The Firm's name should be included on the envelopes of the Price Proposal.
