**1659****HIV/AIDS PREVENTION AND CONTROL PROJECT—LOAN NO. 7184-TR****TENDERS FOR THE REQUEST FOR EXPRESSIONS OF INTEREST FOR THE DESIGN AND IMPLEMENTATION OF AN IT PLATFORM FOR THE SURVEILLANCE INFORMATION SYSTEM AND THE HIV/AIDS/STI CLINICAL MANAGEMENT INFORMATION SYSTEM (CMIS)**

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received a loan from the International Bank of Reconstruction and Development (IBRD) towards the cost of the HIV/AIDS Prevention and Control Project. It is the Government's intention to apply part of the proceeds of this loan to eligible payments for goods, works, related services and consulting services that are to be procured under this project. The National AIDS Coordinating Committee (NACC), which falls under aegis of the Office of the Prime Minister, has been established to execute this project.

The project will require technical assistance to support the Ministry of Health (MOH) and selected Health Facilities in the implementation of an HIV/AIDS/STI Clinical Management Information System (CMIS). The information Technology (IT) platform needed to support and operate the Surveillance Information System and the HIV/AIDS/STI Clinical Management Information System, includes hardware, software, training, technical support, operation and maintenance needs for seven (7) pilot sites, viz., National Surveillance Unit, Queen's Park Counseling Centre and Clinic, Medical Research Foundation, Trinidad Public Health Laboratory, NACC and two (2) private sites.

The proposed system must provide decentralized data entry, processing and access to information at the point of service delivery focusing initially on the pilot sites and must allow for encrypted security via Internet access to private providers. The system should also:

- (a) Provide, adapt and implement HIV/AIDS/STI CMIS initially at the selected pilot sites;
- (b) Support the provider at the point of service with an electronic health record system with real time capabilities, but unique to the requirements of the relevant facility or agency;
- (c) Be designed with a built in mechanism for monitoring and evaluation within and external to the facility or agency and also include variables unique to each point of health care delivery.

To ensure sustainability, implementation would be scheduled in stages reaching fullscale operation by the end of the third year of the project and should include the following consulting services:

Acquisition of applications available in the market, adaptation and implementation of a HIV/AIDS/STI CMIS with electronic health records to adequately support the provider at the point of service with on line diagnosis, treatment, drug prescription cost and outcome assessment of Highly-Active Anti-Retroviral Therapy (HAART) and other relevant information including opportunistic infections;

The capacity to assist the provider with Surveillance and Monitoring of HIV/AIDS/STI.

## EXPRESSIONS OF INTEREST FOR CONSULTING SERVICES FOR THE NATIONAL AIDS COORDINATING COMMITTEE (NACC)

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received a loan from the International Bank of Reconstruction and Development towards the implementation of the HIV/AIDS Prevention and Control Project and it intends to apply the proceeds of the loan towards the procurement of the goods, works, related services and consulting services under this project. The NACC, which falls under the aegis of the Office of the Prime Minister, has been established to execute this project.

The GORTT has developed a five-year National Strategic Plan (NSP) 2004–2008 as the guide to the national response to HIV/AIDS. The NSP has five (5) priority areas:

1. Prevention of the spread of HIV/AIDS
2. Treatment, Care and Support

3. Advocacy and Human Rights
4. Surveillance and Research
5. Programme Management, Coordination and Evaluation

The project seeks to:

- (i) Conduct risk sexual behaviour surveys and research activities that will be used to inform the design and focus of intervention programmes as they will serve to pinpoint the driving force behind the spread of the epidemic.
- (ii) Design and implement a Communications Programme to intensify HIV/AIDS education and awareness using multiple communication channels to target messages for different audiences. The project would also include consultations with stakeholders and line ministries on mass media campaign contents and IEC (Information Education and Communication) materials and the planning production and dissemination of IEC materials for each component intervention, as well as assessments of IEC interventions impact and systematic incorporation of improvements.
- (iii) Solicit the assistance of NGOs, FBOs, CBOs, and other stakeholders that can provide important services for the prevention of the spread of HIV and care for people living with HIV/AIDS.

The NACC Secretariat is therefore desirous of obtaining expressions of interest from firms and individuals for the following consulting services:

- (i) Baseline Surveys: to acquire data on the knowledge, attitude, beliefs and practices of the general population towards AIDS in Trinidad and Tobago. The target population will be males and females within the age group 15–49 years old. (firm)
- (ii) HIV/AIDS Research: that address HIV/AIDS Epidemiology, behavioural changes, clinical and community management of HIV/AIDS and cost-effectiveness of interventions behavioural studies. (individual/firm)
- (iii) Rapid Mapping Exercise: to design and develop a comprehensive inventory and database of all NGOs, FBOs, CBOs, community groups, stakeholders that are actively involved in HIV/AIDS. (individual/firm)
- (iv) Public Relations Campaigns: to promote healthy sexual behaviours among the general population and vulnerable high-risk groups as part of the overall behaviour change intervention strategy and communication programme. The programme will also focus on decreasing stigma on HIV infected pregnant women and fostering sexual behavioural change during major national and cultural festivals. (individual/firm)
- (v) Assessment of Interventions: the assessment of (1) innovative outreach campaigns and interventions (2) IEC materials, i.e., Impact and systematic incorporation of improvements. (individual/firm)
