REQUEST FOR TENDERS FOR THE SUPPLY AND DELIVERY OF MAGAZINES TO THE LIBRARIES OF ALL EXISTING ONE HUNDRED AND THIRTY-FOUR PUBLIC AND ASSISTED SECONDARY SCHOOLS FOR THE MINISTRY OF EDUCATION

The GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through its Ministry of Education (MOE) has accessed loan funding from the Inter-American Development Bank (IDB) for a Secondary Education Modernization Programme (SEMP) in the form of IDB/SEMP Loan 1180/OC—TT. The major goal of the programme being so funded is modernization of the education sector in Trinidad and Tobago.

In order to achieve the aims of, and advancement of, the teaching and learning processes, as well as the development of the reading skills of the students a need has been identified for the sourcing of modern teaching aids in the form of education-oriented magazines.
