TENDERS are invited for the provision of Janitorial/Landscaping and Minor Maintenance Services to various Sport/Youth Facilities of the Ministry of Sport and Youth Affairs for a period of one (1) year.

Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.

Tenders must be accompanied by the following:

- (b) a valid Certificate of Compliance issued in accordance with the National Insurance Act.
