AUCTION SALE OF UNCLEARED FOREIGN USED VEHICLES:

The Port Authority of Trinidad and Tobago wishes to advise that under Section (3) of Act 1978 Chapter 51:05 Re: Disposal of Uncleared Goods Act, Mr. Edward Soon, Auctioneer, has been instructed to sell by Public Auction Uncleared Used Vehicles stored at the Old Spectrum Site located at the western end of Wrightson Road.

DATE OF SALE: 2006 November 07 – TIME: 8.00 A.M.

CONDITIONS OF SALE:

- (1) **Lot Numbers (3) (4) (11) (18) (21) and (23).** These vehicles conform to the Ministry of Trade and Industry guidelines. Approval is granted for the sale of these vehicles to be registered for the roads of Trinidad and Tobago.
- (2) **Lot Numbers (1) (24) (29) and (31) are caravans.** These vehicles conform to the Ministry of Trade and Industry guidelines for commercial vehicles. Approval is granted for sale to a **Registered business only** to be registered for the roads of Trinidad and Tobago.
- (3) The remaining lots will be sold on condition that these vehicles are to be scrapped for spare parts only and will not be registered for the roads of Trinidad and Tobago, due to the year of manufacture.
- (4) **All lots** will require a licence from the Ministry of Trade and Industry (Licensing Unit – TTMA Building, Barataria) for removal.
- (5) All lots will be sold subject to an upset price which will be announced on the day of the sale.
- (6) All lots will be sold on an **“as is” “where is”** basis.

- (7) Notwithstanding, any law to the contrary, a person who purchases vehicle/s at this Auction, shall be entitled to take delivery upon payment of:
 - (a) The purchase price payable to the Port Authority.
 - (b) Customs Duty equivalent to thirty (30%) percent of the sale price shall be payable to the Customs & Excise Division.
 - (c) Any taxes or duties chargeable under any law other than duty imposed under the Customs Act calculated by reference to the purchase price.
- (8) Payment must be made to the Port Authority on the fall of the hammer either by cash or certified cheque. Debit/Credit cards will be accepted.
- (9) Persons failing to comply with condition (8) above will be debarred from further participating in the Auction Sales held by the Port Authority.
- (10) All auctioned cargo must be removed from the Authority's Compound by the respective buyer/s within seven (7) working days subsequent to the Auction Sale, failing which store rent will be calculated, in accordance with the Port Authority's Tariff.
- (11) Items sold, but not claimed and removed by the respective buyers as per (7) above, shall be resubmitted for sale by the Authority at the next Auction Sale.
