APPOINTMENT OF A PRIVATE WAREHOUSE CUSTOMS AREA

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto, to be a private warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of: Messrs. Dufry Trinidad Limited, VIP Area South Terminal Compound, Piarco International Airport—alcohol, tobacco, cigarettes, confectionery, chocolates, perfumes, skin care treatments, cosmetics, jewellery and watches and such goods as I may subsequently approve.
