The GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through its Ministry of Education (MOE) has accessed loan funding from the Inter-American Development Bank (IDB) for the Secondary Education Modernization Programme (SEMP) in the form of IDB/SEMP Loan No. 1180/OC—TT. The major goal of the programme being so funded is modernization of the secondary education sector in Trinidad and Tobago.
