TENDER FOR THE RECONSTRUCTION OF THE SLIPWAY AT THE CARIBBEAN FISHERIES TRAINING AND  
DEVELOPMENT INSTITUTE, MINISTRY OF AGRICULTURE, LAND AND MARINE RESOURCES

TENDERS are invited for the reconstruction of the Slipway at the Caribbean Fisheries Training and Development Institute, Ministry of Agriculture, Land and Marine Resources.

The work will include the following:

- (i) removal of existing slipway and coastal protection material;
- (ii) laying of rock armour for coastal protection;
- (iii) construction of a boat slipway.

Tender documents are available during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.
