- (1) The Medical Professionals Association of Trinidad and Tobago, otherwise known as MPATT (hereinafter referred to as “MPATT”) whether by its President, Vice-President, Secretary, Treasurer, Trustees, Officers, Executive Members, servants and/or agents and/or its members or all workers and/or employees who are Medical Practitioners within the meaning of and/or under and by virtue of the provisions of the Medical Board Act, Chap. 29:50 (hereinafter collectively referred to as “the Medical Practitioners”) and who are employed with the Government/State of the Republic of Trinidad and Tobago and/or the Ministry of Health of the Government of Trinidad and Tobago (hereinafter referred to as “the Government”) and/or Medical Practitioners who are employed with the Government and/or the Regional Health Authorities (as hereinafter defined) or any of them or howsoever otherwise be restrained from taking and/or continuing to take industrial action within the meaning of the Industrial Relations Act, Chap. 88:01 (hereinafter referred to as “the Act”) and in particular sections 65 and 67 thereof and the First and Second Schedules thereto in relation to all public hospitals, health centres, laboratories and/or public health care and/or convalescent facilities or other public health facilities (hereinafter referred to as “the public health care facilities”) owned and/or operated and/or controlled by the Government and/or the North-West Regional Health Authority and/or the Central Regional Health Authority and/or the South-West Regional Health Authority and/or the Eastern Regional Health Authority and/or the Tobago Regional Health Authority [within the meaning of the Regional Health Authorities Act, 1994 (Act No. 5 of 1994) hereinafter collectively referred to as “the Regional Health Authorities”].
- (2) MPATT, its President, Vice-President, Secretary, Treasurer, Trustees, Officers, servants and/or agents and/or its members and/or all Medical Practitioners employed by the Government and/or any and all Medical Practitioners employed by the Regional Health Authorities and who are engaged in industrial action be and are hereby enjoined from taking and/or continuing to take such industrial action within the meaning of the provisions of the Act.
- (3) All the workers and/or employees and/or Medical Practitioners of the Government and/or the Regional Health Authorities and/or members of MPATT shall not take part in and by this Order are restrained from taking and/or participating howsoever otherwise in any industrial action in accordance with section 67(2) of the Act.
- (4) The Order made herein is without prejudice to the Government’s and/or the Regional Health Authorities’ rights under section 63(1)(c) of the Act in relation to all the workers and/or employees and/or Medical Practitioners who are at present engaged in industrial action.
