APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. L. J. Williams Ltd. situate at Lot No. 9, Century Drive, Trincity Industrial Estate, Trincity, viz., Printed Matter, Personal Effects, Pharmaceuticals, Alcohol, Canned Foods, Machinery and Toys and such other goods as I may subsequently approve.

SCHEDULE

An enclosed rectangular area measuring on the north and south 24.27 metres each, on the east and the west 18.20 metres each, comprising a total of 441.71 square metres.

The north wall is constructed of bricks with steel columns and contains a steel door with a wire gate.

The south wall is also constructed of bricks with steel columns and upper galvanized steel sheets to the roof and contains a steel B.R.C. gate.

The east wall is constructed of bricks with steel columns and the west wall is constructed of bricks with steel columns and contains a steel fire escape door.

There is a concrete floor and the roof is constructed of galvanized sheets supported by steel beams.

The building is bounded on the east by Icon Chemicals Ltd. On the north by Trincity Main Road (L. J. Williams—Evo Stick Factory). On the west by Francis Fashions Warehouse and on the south by Century Drive.
