(Liquor Licences Act, Chap. 84:10)

PORT-OF-SPAIN

NOTICE is hereby given that the Licensing Committee for the Licensing District of St. George West, Port-of-Spain Area, has appointed THURSDAY THE 13TH DAY OF DECEMBER, 2007 at after 1.00 o'clock in the noon at the Port-of-Spain Magistrate's Fourth Court 'A' as the day, time and place where applications for Certificates for the issue of New Licences for the period 1st January, 2008 to 31st March, 2008 will be considered.
