

CESSATION OF CONTROL OF FIRST CITIZENS ASSET MANAGEMENT LIMITED

Central Bank Act Chap. 79:02

NOTICE is hereby given in accordance with section 44G of the Central Bank Act Chap 79:02, as amended, that the Central Bank of Trinidad and Tobago (the Central Bank) has relinquished control of **First Citizens Asset Management Limited** (formerly called 'National Commercial Bank Trust Company (Trinidad and Tobago) Limited', 'First Citizens Bank Mortgage and Trust Company Limited', 'First Citizens Trust and Merchant Bank Limited' and 'First Citizens Trust and Asset Management Limited') with effect from 28th September, 2007 (the Effective Date) and all powers of control over the affairs of First Citizens Asset Management Limited vested in the Central Bank by or in consequence of the notification published in the Trinidad and Tobago Gazette (Extraordinary) Vol. 32 No. 233, Item No. 1949 dated 17th September 1993, shall, from the Effective Date, vest in and be deemed to have been transferred to First Citizens Asset Management Limited.
