And upon Mature Consideration and Deliberation it is Ordered that—

- (1) The Public Services Association of Trinidad and Tobago, otherwise known as The Public Services Association (hereinafter referred to as “the PSA”) whether by its President, General Secretary, Treasurer, officers, servants and/or agents and/or its members or all workers/members or employees who are workers of the Trinidad and Tobago Civil Aviation Authority whether Administrative Employees, Professional Employees, Junior Technical Employees and/or Senior Technical Employees thereof (hereinafter referred to as “Civil Aviation Authority Workers”) or any of them or howsoever otherwise known, classified, designated, categorised, called and/or described be restrained from taking and/or continuing to take industrial action within the meaning of the Industrial Relations Act, Chap. 88:01 (“the Act”) in relation to the Piarco International Airport and Crown Point International Airport.
- (2) The PSA, its officers, servants and/or agents and/or its members and/or Civil Aviation Authority Workers engaged in industrial action be and are hereby enjoined from taking and /or continuing to take such industrial relation action.
- (3) Civil Aviation Authority Workers shall not take part in any industrial relations action in accordance with section 67(2) of the Act.
