6. Develops, implements, reviews and refines policies, procedures and systems to ensure support and improve the operational efficiency and effectiveness of the Judiciary.
7. Monitors and reviews case management policies and procedures in accordance with the guidelines approved or established by the Chief Justice.
8. Advises Judges and Judicial Officers on court administration strategies, principles and policies.
9. Serves as Accounting Officer and Procurement Officer of the Judiciary ensuring the efficient provision and use of goods and services.
10. Develops annual budgetary proposals and administers disbursements in accordance with existing financial regulations.
11. Represents the Judiciary at local and international fora.
12. Serves on various committees as directed by the Chief Justice.
13. Serves as Secretary to the Judicial Education Board.
14. Submits reports to the Chief Justice on the operation/accomplishments of the department of Court Administration.
15. Performs any other duties that may be required by the Chief Justice.
