- (1) **Lots (3) to (11)** conform to the Ministry of Trade and Industry guidelines. Approval is granted for the sale of these to be registered for the roads of Trinidad and Tobago.
- (2) **Lot (1) is a Caravan.** This conforms to the Ministry of Trade and Industry guidelines for commercial vehicle. Approval is granted for the sale of said vehicle to be registered for the roads of Trinidad and Tobago.
