APPOINTMENT OF A CUSTOMS AREA (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(3) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Great Foods Limited of 95–96, Frederick Settlement Industrial Estate, Caroni, *viz*, Turkey Emulsion, Turkey Meat, Turkey Parts, Chicken Emulsion, Chicken Meat, Chicken Parts, Beef, Beef Hearts, Pork Bellies, Pork Meat, Pork Parts, various Seasonings, Spices and Preservatives, Curing Agents and Mixes and such other goods as I may subsequently approve.

SCHEDULE

An area measuring 69.34 m by 69.39 m comprising a total area of 4811 square metres, with a two-storey building constructed of steel and concrete with a galvanized steel roof measuring 47.94 m on the north, 48.77 m on the south, 54.86 m on the east and 54.89 m on the west comprising an area of 1500.25 square metres on the Ground Floor and 980.92 square metres on the First Floor, a total covered area of 2481.17 square metres.

The property is bounded on the north by lot 97, on the south by Bejucal Drain, on the east by a Reserve and a Drain and on the west by the Road Reserve.
