Required Qualifications, Experience and Skills

Minimum qualifications—Bachelor of Laws Degree (LLB) and Legal Education Certificate (LEC).

Admission to practice Law in the Republic of Trinidad and Tobago.

LLM (optional).

Minimum experience—Ten (10) years experience as an Attorney-at-law in the following areas: Advocacy, Advisory, Contracts, Commercial Matters, Civil Law and Management Training.

Extensive experience in a Supervisory/Management position in a legal environment.

The Attorney General of the Republic of Trinidad and Tobago.

Position Purpose

The incumbent works with the Attorney General and functions as a principal legal advisor to the State on constitutional matters and all other aspects of civil law. Work includes planning, organizing and directing the work of the Solicitor General's Department; providing legal advice to Government and state agencies on local, regional and international issues; and representing the State in complex legal proceedings.

Major Duties and Responsibilities

Management Responsibilities: 50%—Plans, organizes and directs the work of the Solicitor General's Department.

Advisory: 40%

Litigation: (5%)—Represents the State in constitutional and other civil legal proceedings of a complex nature

Negotiation: (5%)—Functions as the legal representative of the Government, internationally, regionally and locally, in matters involving complex financial constitutional and other civil issues.

Accountability

Complete Responsibility—The incumbent has the relevant authority to take whatever action is deemed advisable or necessary to carry out the duties of the Solicitor General.

Extensive knowledge of the Laws of Trinidad and Tobago

Extensive knowledge of the principles of civil law and the methods and practices of pleadings

Extensive knowledge of the principles and techniques of trial advocacy
