## PRIVATE BILL—AN ACT TO REPEAL AND REPLACE THE PRESBYTERIAN CHURCH INCORPORATION ORDINANCE, 1893 AND PROVIDE FOR THE INCORPORATION OF CERTAIN PERSONS AS TRUSTEES OF THE PRESBYTERIAN CHURCH OF TRINIDAD AND TOBAGO

PUBLIC NOTICE is hereby given in accordance with Standing Order No. 83(3)(b)(i) of the House of Representatives that it is intended to introduce in the House of Representatives the above-mentioned Bill.
