(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 2 of the said Act, do hereby give notice of the appointment of the Sufferance Wharf as indicated hereunder—

SUFFERANCE WHARF

The three (3) piers situate within the Area at Chaguaramas occupied by R.S.R. Holdings Limited, measuring 824.235 square metres, 26.292 square metres and 74.322 square metres located on the sea south of the fabrication and construction facility, for the purpose of wet and dry docking repairs to vessels, including oil rigs and other machinery engaged in the oil and gas industry, refurbishment, refitting and provisioning of marine assets, facilitation and accommodation of Droghers and their cargo, and the bunkering of vessels under such conditions as noted hereunder—

- (a) that no vessel shall bring to in this area without the permission of the Harbour Master, Port Health, the Comptroller of Customs and Excise or other lawful authority, having been first obtained;
- (b) that no cargo shall be loaded on unloaded; except with the written permission of the Comptroller of Customs and Excise;
- (c) that no passengers shall embark and disembark except with the permission of the Comptroller of Customs and Excise having first been obtained;
