THE CARIBBEAN COURT OF JUSTICE (APPELLATE JURISDICTION) (AMENDMENT) RULES, 2010

1. These rules may be cited as the Caribbean Court of Justice (Appellate Jurisdiction) (Amendment) Rules, 2010 and shall come into force on the 11th day of August, 2010.
2. The Caribbean Court of Justice (Appellate Jurisdiction) Rules 2005 are hereby amended:
 - (i) by inserting in Schedule 2 immediately after Part B thereof, a new Part C which is set out in the Schedule hereto;
 - (ii) by inserting in Schedule 4 in the third line of the column headed "Maximum Net Worth" the number "10,000.00" after "BZ\$";
 - (iii) by inserting in Schedule 5 in the third line of the column headed "Amount of Security" the number "15,000.00" after "BZ\$";
