LICENSING SESSION

(Liquor Licences Act, Chap. 84:10)

PRINCES TOWN

NOTICE is hereby given that in pursuance of the Liquor Licences Act, Chap. 84:10 the Liquor Licensing Committee for the Licensing District of Victoria East, Princes Town Area, has appointed MONDAY THE 21ST DAY OF JUNE, 2010 at 9.00 o'clock in the forenoon at the Princes Town Magistrate's Court as the day, hour and place at which a Session will be held for the granting of the Committee's Certificates for the issue of Liquor Licences, for the period 1st July, 2010 to 31st March, 2011.
