(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs: Agostini Limited Group of Companies—klim milk, dry cereals, heinz products, miscellaneous food preparation, alcoholic beverages, pet foods, cosmetic and toilet preparations, photographic materials and such other goods as I may subsequently approve.
