THE CARIBBEAN COMMUNITY (CARICOM) DOMINICAN REPUBLIC
FREE TRADE (ZERO RATE OF DUTY) ORDER, 2011

1. This Order may be cited as the Caribbean Community Citation
(CARICOM) Dominican Republic Free Trade (Zero Rate of Duty)
Order, 2011.

2. This Order is deemed to have come into effect on 1st Commencement
January, 2011.

3. A reduction of the rate of duty to zero has been granted in Grant of
respect of goods imported from the Dominican Republic with headings reduction of
and descriptions in the First and Second Columns, respectively, that duty to zero
satisfy the criteria set out in the Third Column.
