REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND  
ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)  
(CUREPE/SADDLE ROAD/EASTERN MAIN ROAD,  
ARIPO, SANGRE GRANDE/PORT-OF-SPAIN/ST. CLAIR)  
REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control Citation  
(Experimental Scheme) (Curepe/Saddle Road/Eastern Main Road,  
Aripo/Sangre Grande/Port-of-Spain/St. Clair) Regulations, 2011.

2. These Regulations shall have effect from Monday Duration  
21st November, 2011 to Sunday 19th February, 2012.

PART I

CUREPE

3. A person plying a maxi-taxi along the Curepe to Chaguanas Maxi-taxi route  
route, shall do so on the northern and southern lanes of Havelock  
Street, facing east, between Southern Main Road and Broome Street.

4. A person plying a maxi-taxi along the Curepe to Chaguanas No entry to  
route shall not enter— maxi-taxis

- (a) the Southern Main Road, between the Eastern Main Road and Havelock Street;
- (b) Broome Street, between Havelock Street and Evans Street;
- (c) Market Street, between Havelock Street and Evans Street;
- (d) Phillip Street, between the Southern Main Road and McDonald Street;
- (e) Harris Street, between the Southern Main Road and McDonald Street;
- (f) Clifford Street, between the Southern Main Road and McDonald Street;
- (g) McDonald Street, between Phillip Street and Evans Street;  
and
- (h) Evans Street East, between Clifford Street and the Southern Main Road.

One-way traffic 5. A motorist shall proceed in an easterly direction on Havelock Street, between the Southern Main Road and Broome Street.

No plying for hire 6. A taxi-driver may not ply for hire his taxi or maxi-taxi on Broome Street, between Fowler Street and Havelock Street.

Parking prohibited 7. A motorist shall not park his motor vehicle on Agostini Street, Curepe, from Evans Street onwards to a point two hundred metres east.

PART II  
SADDLE ROAD

Parking prohibited 8. A motorist shall not park on Saddle Road, between—  
(a) Blanc Street and Sinanan Street; and  
(b) Sam Boucaud Extension and Cantaro Extension.

PART III  
EASTERN MAIN ROAD, ARIPO

No stopping or waiting 9. A motorist shall not stop or wait on the northern and southern sides of the Eastern Main Road to a point one hundred and fifty metres east and one hundred and twenty metres west of the main driveway of the Immigration Detention Centre, Aripo.

PART IV  
SANGRE GRANDE

Parking prohibited 10. A motorist shall not park on—  
(a) Brierley Street, between Picton Road and Ojoe Road;  
(b) Foster Road, between Brierly Street and Riverside Complex;  
(c) Old Post Office Road, between Eastern Main Road and Railway Road No. 1; and  
(d) Eastern Main Road, between Andrea Street and George Street on the—  
(i) southern side, on Monday, Wednesday and Friday; and  
(ii) northern side, on Tuesday, Thursday and Saturday.

Stopping and waiting prohibited 11. A motorist shall not stop or wait on the northern and southern sides of the Eastern Main Road, between Andrea Street and Ojoe Road roundabout.

12. A person shall not load or off-load a motor vehicle on the northern side of the Eastern Main Road, between Andrea Street and Ojoe Road roundabout. Loading and off-loading prohibited

13. A person shall load or off-load a motor vehicle on the southern side of the Eastern Main Road, between Andrea Street and Ojoe Road roundabout. Loading and off-loading permitted

14. A motorist shall proceed in—

- (a) a westerly direction on the Eastern Main Road, between Wallenvale Road and Railway Road (“Guaico Junction”), from 6.00 a.m. to 9.00 a.m. and from 2.00 p.m. to 6.00 p.m. from Monday to Friday except on a public holiday;
- (b) a southerly direction on Railway Extension Road, between Eastern Main Road and Railway Road;
- (c) an easterly direction on Railway Road, between Railway Road and Eastern Main Road;
- (d) an easterly direction on Brierley Street, between Picton Road and Toco Road;
- (e) a northerly and westerly direction on Henderson Street, between Toco Road and Foster Road;
- (f) a northerly direction on Guaico Village Street No. 1, between Railway Road and Eastern Main Road;
- (g) a southerly direction on Guaico Village Street No. 3, between Eastern Main Road and Railway Road Extension;
- (h) an easterly direction on River Road, between Ojoe Road and Foster Road;
- (i) a northerly direction on Guaico Village Street No. 4, between Railway Road Extension and Eastern Main Road;
- (j) a southerly direction on George Street, between Eastern Main Road and Juteram Street;
- (k) an easterly direction on Canton Street, between Paul Street and George Street;
- (l) a westerly direction on Oxford Street, between George Street and Paul Street;
- (m) a southerly direction on Cunapo Southern Road, between Eastern Main Road and Mary Street;

One-way traffic

- (n) an easterly direction on Mary Street, between Paul Street and Cunapo Southern Road;
  - (o) a northerly direction on Michael Street, between Eastern Main Road and Brierley Street; and
  - (p) a southerly direction on Andre Street, between Eastern Main Road and Cunapo Southern Road.
- No entry 15. A motorist shall not enter Short Street, except maxi-taxis and marked Sangre Grande Regional Corporation vehicles.
- No entry to maxi-taxis 16. A person operating a maxi-taxi—
  - (a) east along the Eastern Main Road shall not proceed along the route beyond Paul Street intersection; and
  - (b) along the Eastern Main Road shall not enter Railway Road No. 1.
- Left turn only 17. A motorist proceeding east along the Eastern Main Road shall turn left at Railway Road (“Guaico Junction”), from 6.00 a.m. to 9.00 a.m. and from 2.00 p.m. to 6.00 p.m. from Monday to Friday except on a public holiday.
- Major/minor Road 18. A motorist proceeding—
  - (a) on Brierley Street at its intersection with Ramdass Street, shall have the right of way; and
  - (b) east on Railway Road and Brierley Street at its intersection with Picton Road, shall have the right of way.
- Maxi-taxi stand 19. A person plying a maxi-taxi along the Toco and Mayaro routes shall do so on the southern side of Brierley Street, facing east (east of Railway Road No. 1) as marked.
- Taxi stand 20. A person plying a taxi along the—
  - (a) Coalmine and Tamana routes shall do so on the southern side of Mary Street, between George Street and Cunapo Southern Road, as marked;
  - (b) Biche and Plum Mitán routes shall do so on the eastern side of Cunapo Southern Road (reversing from Mary Street), between Andre Street and the Paint Shop, facing south, as marked;
  - (c) Mayaro/Toco route shall do so on the area north of Royal Castle (west of the old Bus Terminal compound), as marked; and
  - (d) Quash Trace route (Foster Road taxis) shall occupy Foster Road, north of River Road, as marked.

21. A person shall not ply a maxi-taxi for hire on the Eastern Main Road and on Brierley Street, one hundred metres in either direction from the maxi-taxi hub.

PART V

PORT-OF-SPAIN

22. A motorist proceeding east along Wrightson Road shall not—

- (a) turn right onto Dock Road; or
- (b) make a U-turn at its intersection with Dock Road,

from 6.00 a.m. to 9.00 a.m. from Monday to Friday except on a public holiday.

No right turn  
or U-turn

23. Motorists shall proceed in both directions on Queen Street, between Richmond Street and St. Vincent Street.

Two-way  
traffic

24. A motorist shall not park on—

- (a) Hart Street, from St. Vincent Street to a point thirty metres eastwards;
- (b) Charlotte Street, between Park Street and Independence Square North;
- (c) Queen Street, between Richmond Street and St. Vincent Street;
- (d) Edward Street, between Queen Street and Independence Square North;
- (e) the eastern side of Edward Street, between Queen Street and Sackville Street on Monday, Wednesday and Friday except on a public holiday;
- (f) the western side of Edward Street, between Queen Street and Sackville Street on Tuesday and Thursday except on a public holiday;
- (g) Richmond Street, between London Street and Independence Square North;
- (h) the northern side of Queen Street, between George Street and Chacon Street from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday except on a public holiday;
- (i) the southern side of Queen Street, between George Street and Chacon Street from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday except on a public holiday;

Parking  
prohibited

- (j) the northern side of Prince Street, between George Street and Henry Street from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday except on a public holiday;
- (k) the southern side of Prince Street, between George Street and Henry Street from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday except on a public holiday;
- (l) the eastern side of George Street, between Prince Street and Independence Square North from 10.00 a.m. to 4.00 p.m. on Tuesday and Thursday except on a public holiday;
- (m) the western side of George Street, between Prince Street and Independence Square North from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday except on a public holiday;
- (n) the eastern side of George Street, between Duke Street and Prince Street on Tuesday and Thursday except on a public holiday;
- (o) the western side of George Street, between Duke Street and Prince Street on Monday, Wednesday and Friday except on a public holiday;
- (p) the western side of Henry Street, between Park Street and Independence Square North on Tuesday, Thursday and Saturday except on a public holiday;
- (q) the eastern side of Henry Street, between Park Street and Independence Square North on Monday, Wednesday and Friday except on a public holiday;
- (r) Dundonald Street, between Queen's Park West and Albion Street;
- (s) the northern side of Albion Street, between Dundonald Street and Chancery Lane;
- (t) the southern side of Park Street, from Victoria Square West to Victoria Square East;
- (u) the eastern side of Frederick Street, between Park Street and Independence Square North from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday except on a public holiday; and
- (v) the western side of Frederick Street, between Park Street and Independence Square North from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday except on a public holiday.

25. Vehicular traffic shall proceed in— One-way traffic
- (a) a northerly direction on Stone Street, between Charles Street and Flament Street;
  - (b) an easterly direction on Flament Street, between Stone Street and Scott-Bushe Street;
  - (c) a southerly direction on Scott-Bushe Street; and
  - (d) a westerly direction on Charles Street, between Scott-Bushe Street and Stone Street.

26. Persons operating maxi-taxis shall park as follows: Maxi-taxi stands
- (a) a maximum of sixteen maxi-taxis operating the Port-of-Spain/Petit Valley route shall stand for hire facing north on the western side of Charlotte Street, from a point thirty-five metres south of its intersection with Park Street; and
  - (b) a maximum of ten maxi-taxis operating the Port-of-Spain/Maraval route shall stand for hire facing west on the southern side of Duke Street, between Henry Street and Charlotte Street.

## PART VI

### ST. CLAIR

27. A motorist shall proceed in— One-way traffic
- (a) a southerly direction on Maraval Road, between Marli Street and Tragarete Road;
  - (b) a westerly direction on Rust Street, between Maraval Road and Gray Street;
  - (c) an easterly direction on Alcazar Street, between Maraval Road and Gray Street; and
  - (d) a westerly direction on Herbert Street, between Maraval Road and Gray Street.
28. Motorists shall proceed in both directions on Prada Street, from Newbold Street to Maraval Road. Two-way traffic
29. No motorist shall park on either side of Maraval Road, between Herbert Street and Tragarete Road, from 6.00 a.m. to 6.00 p.m. from Monday to Friday except on a public holiday. Parking prohibited

PART VII

GENERAL

Offence and penalty      30. A person who contravenes any of the provisions of these Regulations commits an offence and is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars and on any subsequent conviction to a fine of one thousand dollars.

Removal and impounding of vehicles unlawfully parked      31. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
