MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER OF TRANSPORT UNDER SECTION 67(1) OF THE MOTOR
VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(SAN FERNANDO) REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (San Fernando) Regulations, 2011.
2. These Regulations shall have effect from Monday 5th December, 2011 to Monday 5th March, 2012. Commence-
ment and
cessation
3. A person driving a motor vehicle— No right turn
 - (a) north along Riverside Drive shall not turn right at its intersection with Lady Hailes Avenue;
 - (b) north along the San Fernando By-Pass shall not turn right at its intersection with Tarouba Road from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays;
 - (c) south along the San Fernando By-Pass shall not turn right at its intersection with Tarouba Road from 6.00 a.m. to 9.00 a.m. and 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays;
 - (d) south along Todd Street shall not turn right at its intersection with Lady Hailes Avenue; and
 - (e) west along Skinner Street shall not turn right at its intersection with Todd Street from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays.
4. A person driving a motor vehicle— Left turn only
 - (a) east along Tarouba Road shall turn left at its intersection with the San Fernando By-Pass from 6.00 a.m. to 9.00 a.m.

and 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays; and

- (b) west along Tarouba Road shall turn left at its intersection with the San Fernando By-Pass from 6.00 a.m. to 9.00 a.m. and 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays.

Parking
prohibited

5. A person driving a motor vehicle shall not park on—
- (a) Carib Street, between Coffee Street and to a marked point eighty metres north;
 - (b) Carib Street, between Howard Lane and Marryat Street;
 - (c) Coffee Street, between Carib Street and Prince of Wales Street;
 - (d) the southern side Park Street;
 - (e) Harris Promenade (north), between Penitence Street and Chancery Lane;
 - (f) Lord Street, between Coffee Street and Mucurapo Street;
 - (g) the western side of Mon Chagrin Street, between High Street and San Fernando Street;
 - (h) Quenca Street, between High Street and St. James Street;
 - (i) Penitence Street, between Harris Promenade and St. James Street;
 - (j) High Street, between Chancery Lane and Pointe-a-Pierre Road;
 - (k) Independence Avenue, between Sutton Street and Keate Street; and
 - (l) Circular Road, between its intersection with London Street and to a point fifty metres east.

No stopping
or waiting

6. A person driving a motor vehicle shall not stop or wait on—
- (a) Circular Road, between its intersection with London Street and to a point fifty metres east; and
 - (b) Carib Street, between Coffee Street and to a point eighty metres north.

One-way
traffic

7. A person driving a motor vehicle shall proceed in a—
- (a) northerly direction on Mon Chagrin Street, between High Street and San Fernando Street; and
 - (b) southerly direction on Penitence Street, between High Street and St. James Street.

-
8. A person plying for hire a taxi along the— Taxi stand
- (a) La Romaine route shall ply on Coffee Street, in the taxi stand with a maximum of twelve taxis facing east;
 - (b) St. John Village route shall ply on the eastern side of Mucurapo Street, in the taxi stand with ten taxis facing south; and
 - (c) Marabella route shall ply on the eastern side of Mucurapo Street, in the taxi stand with ten taxis facing north.
9. A person shall load and off-load a goods vehicle only on the— Loading and off-loading permitted
- (a) northern side Coffee Street, from Prince of Wales Street to a marked point eighty metres north; and
 - (b) northern side of High Street, from a marked point fifty metres from Mon Chagrin Street to a point twenty metres east.
10. A person driving a motor vehicle is permitted to park on— Parking permitted
- (a) the western side of Todd Street, between Park Street and Farah Street;
 - (b) the northern side of Coffee Street, between Prince of Wales Street and Ciperio Street;
 - (c) the northern side of Park Street;
 - (d) the eastern side of Mon Chagrin Street, between High Street and San Fernando Street;
 - (e) Harris Promenade (south), between Paradise Street and Harris Street; and
 - (f) the western side of Quenca Street, between St. James Street and Chacon Street.
11. (1) Subject to subsection (2), a person who contravenes any of the provisions of these Regulations commits an offence and is liable on summary conviction to a fine of seven hundred and fifty dollars. Offence and penalty
- (2) A person who is found guilty of subsequent contravention of any of the provisions of these Regulations is liable on summary conviction to a fine of one thousand dollars.

Removal and
impounding
of vehicles
unlawfully
parked

12. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
