THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, CHAP. 48:50

REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER OF WORKS AND INFRASTRUCTURE UNDER SECTION 67(1)
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(TACARIGUA) REGULATIONS, 2013

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (Tacarigua) Regulations, 2013.

2. These Regulations shall have effect from Monday Duration
9th September, 2013 to Sunday 8th December, 2013.

3. A person driving a motor vehicle shall proceed in—

One-way
traffic

- (a) a northerly direction on Richard Street, from Back Street to Eastern Main Road from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays;
- (b) a northerly direction on Beccles Street, from Back Street to Eastern Main Road from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays;
- (c) an easterly direction on Peters Road, from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays;
- (d) an easterly direction on Bali Street, from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays; and
- (e) an easterly direction on Back Street, between Richard Street and Thavenot Street from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m. Monday to Friday, except on public holidays.

4. A person who contravenes any of the provisions of these Offence and
Regulations commits an offence and is liable on summary conviction to penalty
a fine of seven hundred and fifty dollars and on subsequent conviction
to a fine of one thousand dollars.

Removal and
impounding
of vehicles
unlawfully
parked

5. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
