ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(PRINCES TOWN CHRISTMAS) ORDER, 2014

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Princes Town Christmas) Order, 2014.

2. This Order has effect from Friday 19th December, 2014 to Duration Monday 29th December, 2014.

3. Parking is prohibited on the following:

- (a) Naparima-Mayaro Road, between Lothians Road and King Street; Parking prohibited
- (b) Lothians Road, between Kingsley Street and Naparima-Mayaro Road;
- (c) Bonanza Street, between Armour Street and Naparima-Mayaro Road;
- (d) Charlotte Street, between Aldana Street and Naparima-Mayaro Road;
- (e) King Street, between Naparima-Mayaro Road and M1 Tasker Road;
- (f) Waterlane Street; and
- (g) Cacique Street, between Waterlane Street and Naparima-Mayaro Road.

4. Motorists shall proceed along—

- (a) Lothians Road, between Kingsley Street and Naparima-Mayaro Road in a northerly direction only; One-way traffic
- (b) Railway Road, from Tramline Street in a southerly direction only;
- (c) Waterlane Street, between King Street and Cacique Street in a westerly direction only; and
- (d) Naparima-Mayaro Road, between Lothians Road and King Street in an easterly direction only.

5. (1) Motorists entering Princes Town from New Grant and proceeding west along the Naparima-Mayaro Road shall turn north onto King Street, west onto Waterlane Street and south onto Cacique Street.

(2) Motorists proceeding towards San Fernando along the Naparima-Mayaro Road from New Grant shall turn north onto the M1 Tasker Road or south onto St. Croix Road, west onto Armour Street, north onto Lothians Road and west onto the Naparima-Mayaro Road.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108 of the Motor Vehicles and Road Traffic Act.
