MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SIPARIA KI MAI CELEBRATIONS) ORDER, 2014

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Siparia Ki Mai Celebrations) Order, 2014. Citation

2. This Order has effect from 2.00 p.m. on Thursday 17th April, 2014 to 2.00 p.m. on Friday 18th April, 2014. Duration

3. Vehicular traffic and parking prohibited on—

(a) George Street, between Edward Street and La Pastora Street;

(b) Mary Street, between Edward Street and La Pastora Street; and

(c) La Pastora Street, between Victoria Street and Siparia-Erin Road.

4. Parking is prohibited on—

(a) De Gannes Lane;

(b) Victoria Street, between Coora Road and La Pastora Street;

(c) Siparia Road, between Potter Lane and Siparia-Erin Road;

(d) Edward Street between Mary Street and Siparia-Erin Road;

(e) Coora Road, between Mary Street and Siparia-Erin Road; and

(f) Mary Street, between Station Street and Coora Road.

Parking
prohibited

5. Vehicular traffic approaching Siparia—

(a) from Erin, along the San Fernando-Siparia-Erin Road, proceeding to San Fernando, shall proceed north onto Siparia Road, east onto Gambal Street, south onto Grell Street and east onto San Fernando-Siparia-Erin Road;

(b) from Fyzabad, along Siparia Road, shall proceed east onto De Gannes Lane, south onto Potter Lane and back onto Siparia Road; and

Traffic routes

(c) from Penal, along the San Fernando-Siparia-Erin Road, shall proceed north along Grell Street, onto Gambal Street and onto Siparia Road.

Taxi stand

6. The following taxi stands shall be relocated as follows:

- (a) the Erin Taxi Stand, to the entrance to the Siparia Market;
- (b) the Penal Taxi Stand, to the western side of Bermudez Street at its junction with the San Fernando-Siparia-Erin Road.

Removal and
impounding
of vehicles
unlawfully
parked

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
