THE FINANCE (VARIATION OF APPROPRIATION)
(FINANCIAL YEAR 2016) BILL, 2016

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to vary the appropriation of the sum the issue of which was authorized by the Appropriation (Financial Year 2016) Act, 2015 (Act No. 10 of 2015) and to authorize the utilization of any sums accruing from a reduction in expenditure under certain Heads of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads.

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Finance (Variation of Short title
Appropriation) (Financial Year 2016) Act, 2016.

Interpretation Act No. 10 of 2015	2. In this Act, “the Appropriation Act, 2016” means the Appropriation (Financial Year 2016) Act, 2015.
Increase in Heads of Expenditure Schedule	3. The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 2016 are increased by the amounts specified in the Second Column of that Part.
Reduction in Heads of Expenditure Schedule	4. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2016 are reduced by the amounts specified in the Second Column of that Part.
Sums appropriated in respect of Heads specified in Part II may be utilized Schedule Chap. 69:01 Schedule	5. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2016 and not utilized at the commencement of this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act.
