THE PUBLIC PROCUREMENT AND DISPOSAL OF
PUBLIC PROPERTY (AMENDMENT) BILL, 2016

Explanatory Notes

(These notes form no part of the Bill but are intended only to indicate its general purport)

The purpose of the Public Procurement and Disposal of Public Property (Amendment) Bill, 2016 is to reduce the term of office of the Regulator and other members of the Board, who are appointed under the Public Procurement and Disposal of Public Property Act, 2015, to govern the Office of Procurement Regulation.

The Bill contains two clauses.

Clause 1 of the Bill would set out the short title of the Act.

Clause 2 of the Bill would reduce the term of office of the Regulator from seven years to five years. This clause would also reduce the term of office of the other members of the Board from six years, five years and four years to four years, three years and three years, respectively.

1. This Act may be cited as the Short title Public Procurement and Disposal of Public Property (Amendment) Act, 2016.

2. Section 11 of the Public Procurement and Disposal of Public Property Act is amended—

- (a) in subsection (1), by deleting the word “seven” and substituting the word “five”;
- (b) in subsection (4)(a)(i), by deleting the word “six” and substituting the word “four”;
- (c) in subsection (4)(a)(ii), by deleting the word “five” and substituting the word “three”;
and
- (d) in subsection (4)(b), by deleting the word “four” and substituting the word “three”.
