TENDERS are invited for refurbishment works at two (2) facilities of the Port-of-Spain Corporation, Ministry of Rural Development as follows:

Project 1—Rehabilitation and Renovation Works to the Brian Lara Promenade Male and Female Toilet Facilities.

Project 2—Refurbishment of Central Market Food Court.

Tenders must be accompanied by the following:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender;
- (b) a valid Certificate of Compliance issued in accordance with the National Insurance Act.
