**APPLICATION FOR AN EXPLORATION AND PRODUCTION  
(PUBLIC PETROLEUM RIGHTS) LICENCE  
FOR TABAQUITE BLOCK, TRINIDAD**

PURSUANT to section 7 of the Petroleum Act, Chap. 62:01, notice is hereby given that an application for an Exploration and Production (Public Petroleum Rights) Licence has been made by Petroleum Company of Trinidad and Tobago Limited in respect of the Tabaquite Block comprising approximately 3,036 hectares (7,502 acres) situate onshore Trinidad as described in the map below.
