NEW NATIONAL PROTECTED AREAS SYSTEM

NOTICE is hereby given that the Government of the Republic of Trinidad and Tobago, is modernizing the national protected areas management system in which it is committing to declaring two hundred and fourteen thousand (214,000) hectares of forested lands into a new system. It is the Government's intention to enact the Draft Forestry, Protected Areas and Conservation of Wildlife Bill, which when enacted will facilitate the implementation of the National Forest Policy, the National Protected Areas Policy and the National Wildlife Policy under the new management system.

The Legislation would provide the guidance for the establishment of an appropriate framework for the selection, legal designation and management of a new national system for protected areas. This would include elaboration of a classification system for the designation of a comprehensive and rationalized system of protected areas, the establishment of effective institutional arrangements for management and development of mechanisms for sustainable financing.
