THE ANTI-DUMPING AND COUNTERVAILING DUTIES  
(ANTI-DUMPING DUTY) ORDER, 2016

1. This Order may be cited as the Anti-Dumping and <sup>Citation</sup> Countervailing Duties (Anti-Dumping Duty) Order, 2016.

2. The following anti-dumping duties listed below are imposed on <sup>Anti-Dumping</sup> aluminium extrusions originating in the People's Republic of China and <sup>Duty</sup> found to be dumped:
